All sessions are inclusive of snacks, meals, nappies, resources, & extra-curricular activities, including trips.

Children starting nursery before 9.00am will be provided with breakfast.

Children within our care between 12.00pm - 1.00pm will be provided with a hot lunch.

Children within our care after 4.00pm will be provided with tea.

As we have specific child / staff ratios, we ask that children are not dropped off early / collected late without prior arrangement.

Late fees apply, see terms and conditions on our website for details.

Fees:

Childcare:1 year £9.00 per hour/2 years £8.50 per hour/3-5 years £8 per hour/Funded hour £2Early Start:7.30am - 8.00am £8Additional hour price (excluding meals)1 year £9.50/2 years £9/3-5 years £8.50A non-refundable administration fee of £50 to be paid with your registration to secure your place.11111

Fees are reviewed annually, and we reserve the right to increase fees in line with the UK's cost of living, giving all current parents / guardians at least one months' notice.

Funding:

The Government pays towards your child's nursery hours; however, this does not include snacks, meals, resources, trips and extracurricular activities, nor the expected level of pay for our nursery practitioners. We therefore ask for £2 on all funded hours to cover these additional costs.

Holidays:

Full time: We close for two weeks of the year which are in line with the B&NES school holidays. One at Easter and one at Christmas. We close on all bank holidays.

Term time: We do not offer term time places.

Payment terms:

Payment is one month in advance and should be cleared by the 5th of each month. We require one months' written notice for change of hours or for a notice period. I/We agree to the terms and conditions of this agreement and to the acceptances stated on page two of the Nursery Contract.
